THE PRIMARY SERVICE AREA IS MONTROSE, OURAY AND SAN MIGUEL COUNTIES. MONTROSE MEMORIAL HAD 11,174 INPATIENT VISITS FOR THE YEAR ENDING DECEMBER 31, 2016. MONTROSE MEMORIAL PROVIDES A SIGNIFICANT AMOUNT OF CHARITY CARE AND WROTE OFF \$4,591,651 IN CHARGES FOR THE YEAR ENDING DECEMBER 31, 2016.

OUR GOAL, AT MONTROSE MEMORIAL HOSPITAL, IS TO HELP PATIENTS GET BACK TO LIFE, FAMILY AND FRIENDS AS QUICKLY AS POSSIBLE.
